



BHC OPERATIONAL ACTION DURING LOCKDOWN PERIOD OF GREATER GABORONE

Reference is made to the above subject matter and all correspondences that have been issued to this point regarding Greater Gaborone Lockdown due to an unexpected surge in Covid-19 cases in this particular zone. As you might be aware, the President of the Republic of Botswana His Excellency Dr. Mokgweetsi E.K. Masisi has declared a lockdown for the Greater Gaborone zone with effect from Midnight Thursday July 30th, 2020 for a minimum period of two weeks to enable the Presidential Covid-19 Task Team's containment effort to take place. Therefore, the Corporation has put in place the following measures for the duration of the Lockdown:

BHC GREATER GABORONE BUSINESS OPERATIONS DURING LOCKDOWN

The Corporation's offices in the Greater Gaborone will be operational only with essential services personnel during the period of the lockdown. This therefore means that all other BHC offices which are not part of the Greater Gaborone will continue operations as normal during this period. Contractors engaged on all BHC projects in the Greater Gaborone will also not be on duty throughout this period. Only minimal emergency maintenance services such as pipe bursts and sewage blockage will be rendered on a case by case situation.

MAINTENANCE STANDBY FOR EMERGENCY WORKS

All BHC Maintenance Supervisors and Inspectors in the Greater Gaborone will be on standby to arrange for emergency maintenance works on pipe bursts and sewage blockages only. All maintenance works will be suspended during this period.
